The aim of this Daphne project, ESCAPE, is to foster a trans-national knowledge exchange on methodologies to contrast and prevent violence against children with a migration or minority background. To these ends, the project has carried out a mapping and analysis of best practices in six different European contexts (Bulgaria, Italy, Poland, Portugal, Romania and Slovakia). Based on this and building on the co-operation among NGOs involved in child protection EU-wide, the alliance has developed a trans-national and transferrable violence prevention programme. This programme, also referred to as a 'Toolkit', contains a Practitioner's Training Guide to be used by social workers/operators dealing with the above-mentioned target group, and a selection of life-skills and experiential learning methods for the prevention of street and peer violence and risk behaviours related to harmful lifestyles.

The conference will aim to present the main results of the ESCAPE project; the toolkit and its effective practice-oriented practitioner's training guide for operators dealing with minors victims of violence, and furthermore the promising results obtained in the countries where the Programme was piloted, making of this, a highly successful action.
